People visiting the school do not need to see a red box on the wall with conduit wires etc. nor a transmitter on the outside corner of the school. If any issues arise addressed to the new members of the Township Council by the existing ones and Susan Danson and the Twp. Fire Marshall, please also ask me concerning these as I know about the school somewhat.

One thing past which the Fire Marshall said was he didn't want to harm beams etc below the school in the crawlspace to which I replied-

"The comment about wiring under the school and damaging floors. Go under there buddy and look around !!!!!!!!!!!!!!!

You can crumble the old beams with your hand and watch the dust fall to the ground. Powder post beetles and termites ate them. What the floor is is 2 pressure treated joists sistered and bolted to each floor joist and a big pressure treated laminated beam going down the center under there with steel pole supports into concrete footings. All to stabilize the floor which. The hatchet man sure could drill through walls. Oh, it is so pitiful this bunch of people I talk to.

The historical integrity has been compromised by the box etc. in the schoolroom and the wire transmitter thing outside on the corner. I want that all removed."

Many years and much money has gone into the schoolhouse to restore it over the years. Years were spent getting it to be placed on the National Register of Historic Places. 5,000 dollars was paid to Margaret Westfield to do the formal paperwork to the National Register submitting that it met the qualifications under their guidelines.

All this was disrespected by the manner in which that box was placed in Public View in the schoolhouse room. The new council members offer many in Maple Shade a new hope, including me, that crafty talk will no longer hide incompetence or lack of proper ways things should be done or lack of getting them done.

In the PDF attached I have a plan drawn which gets the box out of public view and again No drilling through any brick walls !
